ANNEXURE**GUIDELINES FOR ENHANCEMENT OF INCENTIVE CASH AWARD SCHEMES**

1. **OBJECTIVES** : The objective of the scheme is to envisage proactive measures for Mizo Educated Youths that lag behind and become increasingly marginalized in the examination conducted by the UPSC. To encourage the Mizo Educated Youths, and to appear more number in these examinations, the State Government provide financial support to candidates clearing the aforesaid examination irrespective of their annual family income.
2. **SCOPE** : Incentive Cash under the scheme will be available for the Mizo candidates who are permanently residing in Mizoram state on clearing the examinations conducted by the UPSC and will be awarded by the Government of Mizoram.
3. **ADMINISTRATIVE AUTHORITY** : The scheme will be implemented and administered by the Mizoram Scholarship Board in accordance with the Regulations in force.
4. **CONDITIONS OF ELIGIBILITY** :
 - (i) Candidate should be a Mizo permanently residing in the State of Mizoram.
 - (ii) Applicant should not be covered under any other Scholarship scheme.
 - (iii) Under this scheme, upto 2 (two) chances will be allowed for claiming Cash Incentive Awards to those qualified candidates in the written examinations conducted by the UPSC subject to production of declaration certificate from the conducting authority.
 - (iv) The successful candidates should submit their claims to the Secretary, Mizoram Scholarship Board, with all necessary supporting documents indicated in the form. Such as the respective Institutions indicating name of Centre of Examination, Roll No. Date of Examination and permanent Address
5. **VALUE OF SCHOLARSHIP** :
 - i) Successful candidate shall be given a sum of Rs 1,00,000/- (Rupees One lakh)
 - ii) Re-imburement of Course fee may be given only to those candidates who have successfully qualified themselves in the Preliminary Examination and the amount of re-imburement should be the actual course fee paid to the coaching Institution or Rs.20,000/- (Rupees twenty thousand) only, whichever is less.
 - iii) Uniform payment of Hostel/Mess fee @ Rs.2000/- per month shall be given to successful candidates towards re-imburement of Hostel/Mess fees incurred by him/her on production of a certificate from the concerned Institution to that effect. Payment for re-imburement of Hostel/Mess fees should be restricted to the limit of 6 (six) months.
6. **MODE OF PAYMENT** : Successful candidate in the above competitive examination may claim the cash award to Mizoram Scholarship Board in a prescribed application format by furnishing all necessary documents mentioned in the application form.
7. **CHANGES IN THE SCHEME** : Regulations governing the scheme may be changed by the Government of Mizoram at any time as and when considered necessary.

The Application form shall be obtained from the Office of the Secretary, Mizoram Scholarship Board, Mizoram and the following documents, after duly attested, should be enclosed in the applications :

 - i) Copy of Aadhar or any other identification paper/document
 - ii) Copy of Call letter/Intimation letter
 - iii) Copy of Permanent Residential Certificate
 - iv) Copy of Receipt of Course Fee etc
